#### IV. APPROVAL OF MINUTES PUBLIC SESSION:

The minutes of the public session of the Audit Committee meeting of November 5, 2019 in San Antonio, TX were approved by a voice vote with a motion by Lee Baerlocher, MT.

#### V. <u>AUDIT DIRECTOR'S REPORT</u>

Holly Coon, Audit Director, referred to her written report on the status of the Audit Program. For the first three quarters of 2020 FY, the MTC Audit Program completed parts of nine corporate income tax audits. The Audit Program also completed five sales tax audits and parts of nine other sales tax audits. The proposed assessments for the first quarter were \$144,288,206 for corporate income tax and \$1,833,091 for sales tax. There are nineteen (19) income and thirty-five (35) sales tax audits in progress.

Holly also highlighted a few other items on the report.

First, Holly mentioned that the Chicago Audit Office closing has been delayed due to the COVID-19 pandemic but the office must close by July 2020 and noted the new address for the Joint Audit Program.

Second, Holly addressed staff changes reporting that two new income tax auditors were added to staff since the committee met in San Antonio, TX and indicated that the program will be adding a new administrative assistant in the Washington DC office to replace Michelle Becker who is assigned to the Chicago office that will soon close.

Third, Holly referred to the training that the audit staff had conducted in the current fiscal year and noted that the Corporate Income Tax training has been delayed until October. This training will not be sponsored by a state, so early registrations are essential to ensure the training will move forward as planned. Holly also noted that the MTC staff has provided training via webinar and states can expect more training available via webinar in the future.

#### VI. <u>NEW BUSINESS AND ADJOURNMENT</u>

There was no other new business to discuss and the public session ended at 2:23 P.M. Eastern Time by a motion from Lee Baerlocher, Montana, so the committee could hold a closed session.

Due to complexities of holding the Audit Committee meeting via teleconference, the public session was not reopened at the conclusion of the closed session, as is customary. Frank notified meeting participants that any items from the closed session appropriate to be reported in public session would be presented at the next public session of the Audit Committee.
