VI. <u>AUDIT DIRECTOR'S REPORT</u>

Keith Getschel, Audit Director, referred to his written report on the status of the Audit Program. For the fiscal year 2019, through September 30, 2018, the MTC Audit Program completed two corporate income tax audits and parts of four other corporate income tax audits. The Audit Program also completed two sales tax audits and parts of five other sales tax audits. The proposed assessments for fiscal 2019 through September 30, 2018 were \$30,746,066 for corporate income tax and \$804,221 for sales tax. There are twenty-two (22) income and thirty-one (33) sales tax audits in progress.

Keith introduced and welcomed Jackie Dalenberg, a sales tax auditor.
