#### **IV.** Review Proposed SITAS Committee Charter

Holly also reported that the proposed charter was drafted by the MTC legal team as an organization wide effort to update MTC committee charters.

#### V. Review Revised Information Exchange Agreement

Holly Coon, MTC, reviewed the revised State Intercompany Transactions Advisory Service Committee Participation Commitment and Exchange of Information Agreement noting that the agreement had been revised to delete any commitment by the signatory state to participate in a SITAS program, should one ever be created, within the Commission.

Krystal Bolton asked if any of the meeting attendees had any questions, concerns or recommendations relating to the revised agreement and none were provided. Krystal also asked participating state representatives to report on the status of the agreement within their agency. Some responding representatives indicated that the agreement was under review within their agency while others indicated that it would be signed soon.
