Uniformity Proposal Before the Commission: Model Uniform Statute for Reporting Adjustments to Federal Taxable Income and Federal Partnership Audit Adjustments

Helen Hecht, General Counsel, presented the proposal. She served as the hearing officer for the project. She noted that the meeting agenda contains links to all the relevant portions of the project, including the web page, the final product, and the hearing officer report. If adopted, the model would be published with drafters' notes which are very similar to those in the hearing officer report. She has received nonmaterial comments on the drafters' notes. There have been no further developments since this matter was last considered by the executive committee.

Randy Tilley, Idaho, moved to adopt the model and report. There was no debate on the motion. The motion passed by roll call vote, with 11 states for, totaling 81.72% of the population of member states in favor. No state opposed the motion and 5 states were absent.
