#### **III. PUBLIC COMMENTS:**

There were no Public Comments.

### IV. APPROVAL OF MINUTES PUBLIC SESSION

The minutes of the public session of the Audit Committee meeting on November 10, 2021, in Alexandria Virginia, were approved unanimously with a motion to approve made by Michael Williams, Alaska.

#### V. AUDIT DIRECTOR'S REPORT

Holly Coon referred to her written report and highlighted certain items from the report. Holly reported that during the first three quarters of the fiscal year had proposed assessments for income tax of just over \$93 Million and NOL/tax credit reductions of \$2.3 Million. The sales tax program had proposed assessments of \$3.4 Million. Holly also highlighted the staffing changes. George Fung, a long-time sales tax auditor with the Commission, retired in March. The Commission will likely hire a sales tax auditor after extension contracts are received for the next fiscal year. Melody Moncrief joined the audit team in March as a part-time administrative assistant. Finally, Holly noted the training section of the report. She advised the committee that the market sourcing training recordings were complete but still being edited. State representatives can stay up to date on MTC training via the MTC monthly newsletter.

#### VI. SALES TAX SAMPLING POLICY AND GUIDELINES MANUAL

Frank indicated that MTC staff revised the Sales Tax Sampling Policy and Guidelines Manual and noted that a link was provided to committee members to the document and the document was available on the MTC website for public review. Committee members voiced no questions or concerns about the revised manual and a motion was submitted by Bryan Kelly, Washington, to approve the manual as proposed. Frank exercised his right to limit the vote to states participating in the sales tax program and the motion passed with a roll call vote.

#### VII. <u>NEW BUSINESS AND ADJOURNMENT</u>

As an item of new business, Holly announced that the Commission would be moving to Box as a tool to transmit confidential information for the audit program. She explained that Cleo, the Commission's current secure platform software, is no longer a viable option. Holly Coon previewed the new vendor's website portal and shared that the IRS has accepted a Box implementation for IRS-1075 use. Commission IT staff will configure the Box platform for this standard which will require two factor authentication.

There were no other items of new business and the public session was recessed at 2:01 P.M. Mountain Time with a motion from Michael Williams, Alaska.

At the conclusion of the closed session, the public session was reopened at 5:53 P.M. Mountain Time. With no items to report from the closed session, the public session was adjourned with a motion from Katie Lolley, Oregon at 5:54 P.M. Mountain Time.
