#### III. PUBLIC COMMENTS:

There were no Public Comments.

### IV. APPROVAL OF MINUTES PUBLIC SESSION:

The minutes of the public session of the Audit Committee meeting on April 21, 2020 conducted via teleconference were approved unanimously with a motion by Lee Baerlocher, MT. Since the April meeting of the committee was conducted via teleconference, the public session was not reopened at the conclusion of the closed session. Instead, guests were instructed that any items to report from the closed session would be reported at the beginning of the next committee meeting scheduled for July. Frank notified members and guests that there were no items to report from the closed session in April.

## V. AUDIT DIRECTOR'S REPORT

Holly Coon, Audit Director, referred to her written report on the status of the Audit Program. She noted that for the 2020 fiscal year, the Joint Audit Program proposed assessments of \$181,954,548 for completed and partially completed corporate income tax audits and \$1,625,565 for completed and partially completed sales tax audits.

Holly also reminded the Audit Committee that the Chicago Audit Office is now closed, and the Commission lost Michelle Becker as part of this process. Michelle served as the Joint Audit Program's administrative assistant and was assigned to the Chicago office. The Joint Audit Program does plan to hire a replacement for Michelle who will be assigned to the Commission's Washington DC office. However, the hiring process has been placed on hold due to the COVID-19 pandemic.

The third item Holly highlighted was the training portion of the report. She quickly referenced the training the Joint Audit Program staff conducted in last fiscal year and discussed in more detail the two upcoming training sessions the Commission plans to conduct in the coming months.

- 1. A multi-session, market-based sourcing training to be conducted by Holly and Michael Fatale (MA). This training will be provided virtually starting in late August or September.
- 2. A virtual general corporate income tax training course. This training will be provided in lieu of an in-person corporate income tax course originally planned as an in-person training in June 2020 in Virginia and then rescheduled for October 2020. The Commission is in the preliminary stages of planning this training.

Exact dates, times, and fees are still being determined for both trainings.

Finally, Holly remarked that this was the first meeting in which taxpayers could submit audit narratives to be included in the audit packet alongside staff provided audit narratives. Notices were sent to taxpayer contacts with on-going MTC audits notifying them of this opportunity. Two taxpayer narratives were received and those were included in the audit packet for discussion in the closed session of the meeting.

#### VI. <u>NEW BUSINESS AND ADJOURNMENT</u>

There was no other new business to discuss and the public session ended at 2:20 P.M. Eastern Time by a motion from Lee Baerlocher, Montana, so the committee could hold a closed session.

Due to complexities of holding the Audit Committee meeting via teleconference, the public session was not reopened at the conclusion of the closed session, as is customary. Frank notified meeting participants that any items from the closed session appropriate to be reported in public session would be presented at the next public session of the Audit Committee.
