III. <u>REPORT ITEMS FROM CLOSED SESSION-AUGUST 10, 2021</u>

Due to the virtual nature of the Summer Audit Committee meeting, the public session was not reopened after the closed session. Frank stated that during the closed session of the summer meeting, the committee discussed a request by a taxpayer representative to be informed of the state that nominated his employer for audit and the reasons the state provided for the nomination. The committee directed MTC legal staff to draft a policy stating that MTC audit staff may not divulge the nominating state's name or reasons for an audit nomination.

IV. <u>PUBLIC COMMENTS:</u>

V. <u>APPROVAL OF MINUTES PUBLIC SESSION</u>

The minutes of the public session of the Audit Committee meeting on August 10, 2021 conducted via teleconference were approved unanimously with a motion by Jordan Raye, KS.

VI. <u>AUDIT DIRECTOR'S REPORT</u>

Holly referred to her written report on the status of the Audit Program. She noted that during the first quarter of the fiscal year, the income tax program proposed net assessments of \$5,526,429 for partially completed income tax audits. Income tax program staff also proposed NOL and refund reductions of \$68,324. The sales tax program proposed net assessments of \$2,057,431 for completed and partially completed sales tax audits. Currently, there are eighteen (18) income tax audits and twenty-seven (27) sales tax audits in progress.

Holly also highlighted the training portion of the report. The Commission has two upcoming training events: Applying Public Law 86-272 to Modern Business Activities on December 1st and CLE/CPE Ethics and Confidentiality Extravaganza on December 14th. Both training events will be held virtually and open to all state tax administrators and state legal counsel, but not open to the public.

Regarding roundtable discussions, Holly noted that the next audit roundtable will be held December 8th at 2:00pmET and the topic is Section 17 with a focus on income producing activity as determined by cost of performance. Audit roundtable sessions are training and informational sessions, not Audit Committee meetings. Participants must be authorized to share and receive confidential information on behalf of their state to participate.

VII. <u>REVIEW PROPOSED POLICY- MTC EMPLOYEES CANNOT DISCLOSE</u> <u>NOMINATING STATE</u>

Frank referred the committee to the proposed policy. John Ficara, NJ moved that the committee adopt the policy as proposed. The motion passed by a large margin.

VIII. <u>NEW BUSINESS AND ADJOURNMENT</u>

There was no other new business to discuss and the public session was recessed at 8:52 A.M. by a motion from Christy Vandevender, AL so the committee could hold a closed session. The public session was reopened, and the meeting was adjourned at 12:03 P.M.
