III. <u>PUBLIC COMMENTS:</u>

There were no members of the public present at the meeting.

IV. <u>APPROVAL OF MINUTES PUBLIC SESSION:</u>

The minutes of the public session of the Audit Committee meeting of July 23, 2013 in San Diego were approved.

V. <u>AUDIT DIRECTOR'S REPORT</u>

Les Koenig, MTC Audit Director referred to his written report on the status of the Audit Program. The MTC Audit Program completed 1 income tax audit and parts of 6 other income tax audits during the first four months of the fiscal year end 6/14. The Audit Program also completed 1 sales tax audit and parts of 4 other sales tax audits. The proposed assessments to date for the fiscal year end 6/14 were \$8,955,049.

Les reported that two income tax auditors are no longer in the commission's employ as of November 1, 2013. These two positions will be filled after the new Audit Director is hired in early 2014.

In advance of the meeting Rick DeBano requested that Les discuss the increase in the average hours per state in fiscal years ended 6/11 and 6/12. Les referred to the Audit Hour Analysis in the report and explained that fewer audits were totally completed in those two years due to a few large bank audits that took more time to complete. There was also a change in reporting during that time frame and the partially completed audits are not reflected in this report.

Joe Huddleston reported that at the beginning of 2014 the Audit Director position will be posted on the MTC website. The vacant auditor positions will be filled sometime during the second quarter. He said that Les will be recognized at the MTC's Annual Meeting in New Mexico.
