V. <u>AUDIT DIRECTOR'S REPORT</u>

Les Koenig, MTC Audit Director issued a written report on the status of the Audit Program. The MTC Audit Program completed 2 and parts of 3 sales tax audits. The Audit Program also completed 2 and parts of 4 income tax audits through September 30 of fiscal year end 6/13. The total proposed assessments currently for the year were \$3,880,837. Les also reported that two vacancies exist for the audit program. The positions of Administrative assistant and a sales tax auditor are expected to be filled by January 1, 2013.

VI. STRATEGIC PLANNING

Les reported on status of the strategic planning process. The executive committee approved to move forward with 2 separate areas. The first is no change audits, Frank Hales is chairing that group with Cathy Felix and Steve Yang from MTC staff. Frank is still asking for additional state support. The second group is considering ways to improve audit selection process. Rick DeBano is chairing that group with Lee Baerlocher, Randy Tilley, Les Koenig and Harold Jennings on the committee. Elizabeth Harchenko is facilitating both groups.

VII. <u>NEW BUSINESS AND ADJOURNMENT</u>

Rick DeBano suggested that the audit committee resume meeting in person for the fall meeting to coincide with uniformity committee meeting. The audit committee supported the request and next fall the audit committee will have an in person meeting.
