IV. APPROVAL OF MINUTES PUBLIC SESSION:

The minutes of the public session of the Audit Committee meeting of July 27, 2015, in Spokane, Washington were approved with a motion by Lee Baerlocher.

V. <u>AUDIT DIRECTOR'S REPORT</u>

Keith Getschel, Audit Director, referred to his written report on the status of the Audit Program. For the fiscal year end, 6/30/16, the MTC Audit Program has completed parts of 7 income tax audits. They have also completed 3 sales tax audit and parts of 7 others. The proposed assessments for the fiscal year ended 6/30/16 through October 31, 2015 were \$28,927,858 for income tax and \$4,190,984 for sales tax.

Keith reported that New Hampshire joined the MTC audit program and he welcomed New Hampshire to the meeting.

Keith reported that the commission hired a new sales tax auditor in September, Bartt Stucki. Bartt came to the commission from the state of Utah. Keith also reported the retirement of Marie Plesko and thanked her for her many years of service to the commission. This vacancy has been posted and interviews will start the first week of January, 2016.

Keith reported on the training events audit staff participated in so far this fiscal year. Harold Jennings, Bob Schauer and Sam Moon conducted a "Statistical Sampling for Sales and Use Tax Audits" class September 21 through the 24th in Des Plaines, Illinois. Harold Jennings and Bob Schauer conducted a "Computer Assisted Audit Techniques using Excel" class in Trenton New Jersey, October 6th and 7th.

Keith reported that the MTC audit program supervisors and director met with Greg Matson, Helen Hecht and Bruce Forte on October 19, 2015 in Des Plaines, Illinois, to discuss audit issues and problems that had surfaced on some pending audits.

Keith reported that the Audit Phase 2 Planning Team had submitted to him recommended projects relating to the "Organizational Support Goal" Although

he has reviewed those recommendations he has not had a chance to discuss the proposals with Greg
