IV. APPROVAL OF MINUTES PUBLIC SESSION:

The minutes of the public session of the Audit Committee meeting of July 29, 2014 in Albuquerque and teleconference meeting of October 30, 2014 were approved with a motion by <u>Frank Hales.</u>

V. <u>AUDIT DIRECTOR'S REPORT</u>

Keith Getschel, Audit Director, referred to his written report on the status of the Audit Program. Since the last committee meeting, the MTC Audit Program has completed 2 income tax audits and parts of 3 others. They have also completed 1 sales tax audit and parts of 6 others.

Keith reported that the 2 audit staff positions were filled as 2 income tax auditors were hired (Lindsay Buerkle in November and Pamela Downs, to start in January 2015).

Joe Huddleston reported that contracts were consummated for 3 states to join the MTC Audit Program; Pennsylvania, Rhode Island, and Iowa. These states are joining for just corporate income taxes.

Keith took the time for the audit committee to acknowledge Rick DeBano for his outstanding service as the chair of the MTC Audit Committee for the last few years, as Rick is retiring from Wisconsin in early 2015.

The process to replace the Audit Committee Chair is to select the current vicechair, Frank Hales of Utah, to replace to outgoing chair. There was no objection from the Audit Committee. A volunteer to replace Frank Hales as vice chair was requested. Frank Hales nominated Lee Baerlocher of Montana. Lee agreed to volunteer and there was no objection from the Audit Committee.

Ken Beier provided an update on the MTC training schedule.
