VI. <u>AUDIT DIRECTOR'S REPORT</u>

Keith Getschel, Audit Director, referred to his written report on the status of the Audit Program. For the first quarter of fiscal year 2018, the MTC Audit Program has completed parts of six income tax audits. They have also completed one sales tax audits and parts of three other sales tax audits. The proposed assessments for the first quarter of fiscal year ended 6/30/18 are \$6,066,392 for income tax and \$118,848 for sales tax. There are twenty-one (22) income and thirty-three (31) sales tax audits in progress.

Keith reported that Louisiana joined the MTC's Joint Corporate Income Tax Audit Program. Louisiana was a member of the MTC's Joint Sales Tax Program, so they will now be a member in both programs. Keith also reported that Iowa joined the MTC's Joint Sales Tax Audit Program. Iowa was a member of the MTC's Joint Corporate Income Tax Audit Program, so they will now be a member in both programs.

Keith introduced and welcomed Lindsay Buerkle, a corporate income tax auditor with the MTC.
