## Public Comment

#### <u>Minutes</u>

Frank Hales (UT) moved for approval of the minutes of the August 21, 2022 open session portion of the Nexus Committee meeting, and the minutes were approved by unanimous voice vote.

# Nexus Director's Report and Update on Recent Nexus Law Developments since April 21, 2022

Richard Cram, Director of the National Nexus Program, reviewed for the Committee his Update on Recent Nexus Law Developments since April 21, 2022 and the FY 2022 Nexus Program Director's Report. Back tax collections from agreements closed as of June 30, 2022 were \$28,337,506 with 493 executed agreements. Richard advised

that an income tax Nexus School is tentatively being scheduled for Oregon in October 6-7, 2022. He encouraged other states interested in hosting one to contact MTC training staff.

# Upcoming Strategic Planning Committee Survey Regarding MTC Mission, Vision, and Values

John Ficara (NJ), Chair of the Strategic Planning Committee, reported that a survey is being drafted to send out member states in the Commission to seek input for updating the Commission's "Mission, Vision, Values" statement. The survey should be finalized at the upcoming Strategic Planning Committee meeting and it will then be ready to send out for responses from the states.

# Presentation by Clinton Singletary on creation and current status of Alaska Remote Sellers Sales Tax Commission (ARSSTC)

Clinton Singletary, Program Director, (ARSSTC) gave a Powerpoint presentation (posted on the MTC website) providing an overview of the ARSSTC, which was established after *Wayfair* to allow local governments in Alaska that have imposed local sales taxes to join the ARSSTC in order establish sales tax economic nexus pursuant to its provisions for centralized administration.

## Presentation by Richard Cram on introduction to cryptocurrency tax issues

Richard Cram presented a brief Powerpoint to explain what cryptocurrency is and identify the tax guidance concerning cryptocurrency that the IRS and a few states have published.

# Presentation by Norm Hannawa of Chainalysis on effective use of technology tools in cryptocurrency tax audits

Mr. Hannawa gave a Powerpoint presentation on information publicly available on cryptocurrency transactions and audit techniques that can be used to glean data from that information useful for tax compliance purposes.

#### Annual Review of Nexus Committee Charter

Chair Bryan Kelly called to the Committee's attention the Nexus Committee Charter approved by the Executive Committee in August 2021and asked if anyone had

suggested changes concerning that document. No changes were suggested, so Chair Bryan Kelly advised that the annual review of the Charter is considered completed.
