## **National Nexus Program (NNP) Director's Report for FY 2022 August 1, 2022**

### Multistate Voluntary Disclosure Program (MVDP)

The Nexus Program results for FY 2022 (July 1, 2021 through June 30, 2022) are provided below.

- Nexus states' collections: \$28,337,506 (FY 2021: \$20,269,587)
- Nexus states' executed agreements: 493 (FY 2021: 411)
- Nexus states' average contract value: \$57,480 (FY 2021: \$49,318)

The above amounts include checks received by the Commission or amounts paid by the taxpayer directly to the states and reported to the Commission. Interest on back tax paid and the value of a new taxpayer are not included. Applications continue to increase in the post-*Wayfair* era above what they were before that decision. The Commission received applications from 192 taxpayers in calendar year 2021. So far this calendar year 2022 (as of June 30, 2022), 94 taxpayers have applied. Most of the applications continue to be based on sales tax economic nexus.

### Membership

There are currently thirty-nine participating states (including the District of Columbia) in the NNP. Commission staff continues to reach out to non-member states.

### Outreach

virtual presentation on September 14, 2021 on MyCPE.com platform describing voluntary disclosure using the Multistate Voluntary Disclosure Program;

co-panelist at Paul J. Hartman SALT Forum in Nashville, TN on October 28, 2021 with Steve Jasper, Jessica Morgan, and Victoria Torchen in session entitled: "You Sneezed! What Isn't Nexus Anymore?";

virtual presentation on March 15, 2022 on CPAacademy.org platform describing basics of income and sales tax nexus, and voluntary disclosure using the Multistate Voluntary Disclosure Program.

Staff continues to urge states to put a link to the NNP on their voluntary disclosure web pages.

### Nexus School
