V. APPROVAL OF MINUTES OF PUBLIC SESSION ST LOUIS, MO.

The minutes from the St Louis, MO. public session held on November 15, 2006 were approved as submitted.

VI. AUDIT DIRECTOR'S REPORT

Les Koenig, MTC Audit Director issued a written report on the status of the Audit Program. The MTC Audit Program completed 8 sales tax and 4.5 income tax audits through January 31, 2007 of fiscal year end 6/07.

Les also reported that he and Cathy Felix were instructors for an income tax training class that was held in Oklahoma City during February 2007.

Les also reported that two additional auditors were hired. Robert Schauer from Washington was hired as a Computer Audit Specialist effective December 4, 2006. Dave Nowak from Ohio Department of Revenue was hired as an Income Tax Auditor effective January 29, 2007.

Les reported on the work of updating the MTC Income and Sales Tax Manuals. He distributed a draft of the revised index for each manual. It is anticipated that this work will not be concluded before the end of calendar year 2007.
