# III. Approval of Minutes of the Strategic Planning Committee Meeting on Tuesday July 25, 2023

Greg Matson, as committee vice chair, moved for approval of the minutes as written. The motion passed by voice vote.

#### III. Public Participation Policy Revision Project

Mr. Matson discussed the current status of the public participation policy (PPP) revision project and the need to make changes to update and restructure the PPP. He and General Counsel Nancy Prosser have developed a working draft that they will be ready to share with committee members and the public soon. The proposed revisions to the PPP will retain the various components of the current PPP and will not change the way MTC meetings have been conducted for decades. It will group related provisions to make following it easier and will be adapted to modern ways meetings are conducted. Instead of consisting of 28 sections as per the current policy, the revision proposes a new structure group into six or seven sections.

The revised draft will be presented at a future committee meeting or two before the inperson MTC spring committee meetings. The committee will review the proposed changes and then conduct a public hearing, if approved by the Executive Committee at its meeting later today.

Frank Hales (Utah) moved to approve the process for the PPP revision project as outlined in the memo and recommend the Executive Committee approve a public hearing to held in time for the Executive Committee to consider the matter at its meeting in the spring. The motion passed by voice vote.

## **IV.Update on Training Activities**

Scott Pattison, deputy executive director, noted that the Commission is now doing virtual and in-person training and looks forward to receiving feedback from the committee. MTC staff recently finished teaching a virtual statistical sampling class and continues to produce material and refine the learning management system.
