Bryan Kelly, Chair (WA), brought the meeting to order at 8:30 am EST, introductions of attendees were made, and public comment was invited.

Public Comment

No public comment was offered.

<u>Minutes</u>

Brendon Reese (CO) moved for approval of the minutes of the July 24, 2023 open session portion of the Nexus Committee meeting, and the minutes were approved by unanimous voice vote.

Nexus Director's Report and Update on Recent Nexus Law Developments since July 24, 2023

Richard Cram, Director of the National Nexus Program, reviewed for the Committee his Update on Recent Nexus Law Developments since July 24, 2023 and the First Quarter FY 2024 Nexus Program Director's Report. Back tax collections from agreements closed between July 1, 2023 and September 30, 2023 were \$2,123,382 with 67 executed agreements. Richard advised that a Nexus School is tentatively being scheduled to be held in Charleston, WV in May of 2024, and the dates and registration information will be posted when those arrangements are finalized. He encouraged other states interested in hosting one to contact MTC training staff.

<u>Presentation by Michael Hilkin, attorney at McDermott Will & Emery's New York City office, on compliance challenges of local taxes</u>

Michael Hilkin presented Powerpoint slides and discussed the difficulties that remote sellers and marketplace facilitators face in attempting to get information and comply with locally administered local excise taxes and local permit or registration requirements, as well as audits. Michael acknowledged that states with locally administered local sales taxes, such as Alabama, Colorado and Louisiana, have made efforts toward centralizing administration of those taxes, but more work needs to be done. He noted that locally administered excise taxes impose a burden on remote sellers, which could raise Commerce Clause and Due Process issues. Michael urged the Nexus Committee to consider taking up a project to encourage administrative simplification and uniformity of local tax systems.
